

# How to contact Child Protection



If you or someone you know is in immediate danger, phone 911.

If you suspect that a child may be abused, neglected or exposed to family violence, phone your local Child and Family Services Authority (see below), the Child Abuse Hotline at 1-800-387-KIDS (5437), or the police.

For information about family violence resources available in your community, phone the 24-hour Family Violence Info Line at 780-310-1818, toll-free in Alberta, or visit [www.familyviolence.gov.ab.ca](http://www.familyviolence.gov.ab.ca).

There are nine provincial regions, each of which has a dedicated Child and Family Services Authority. 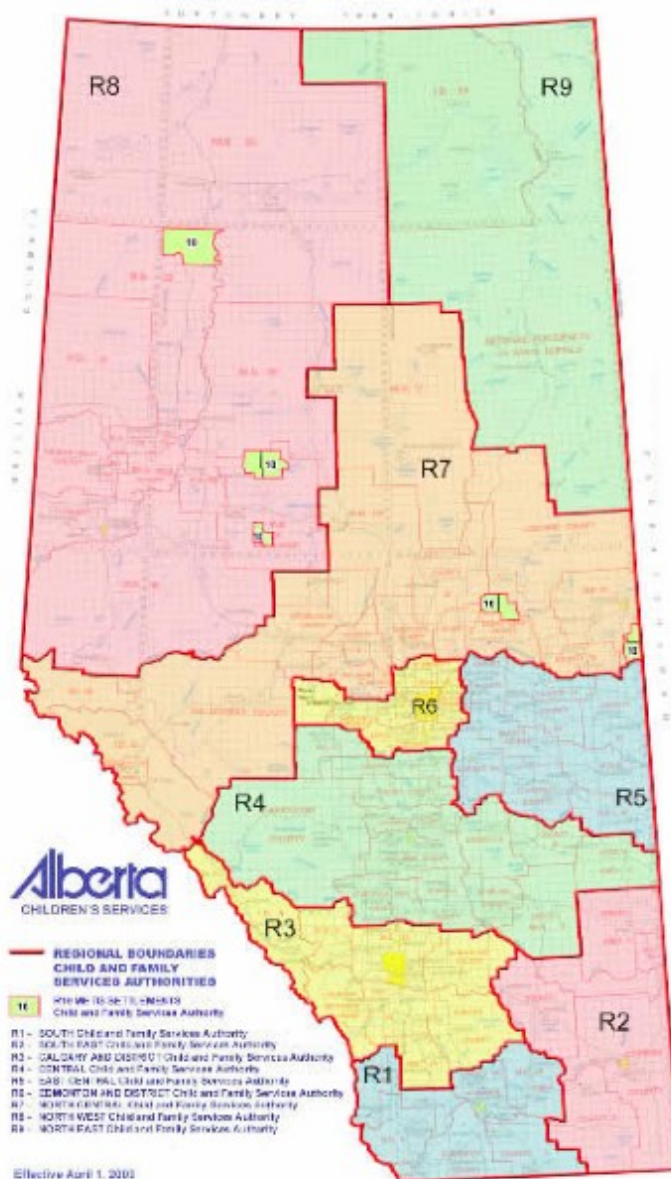

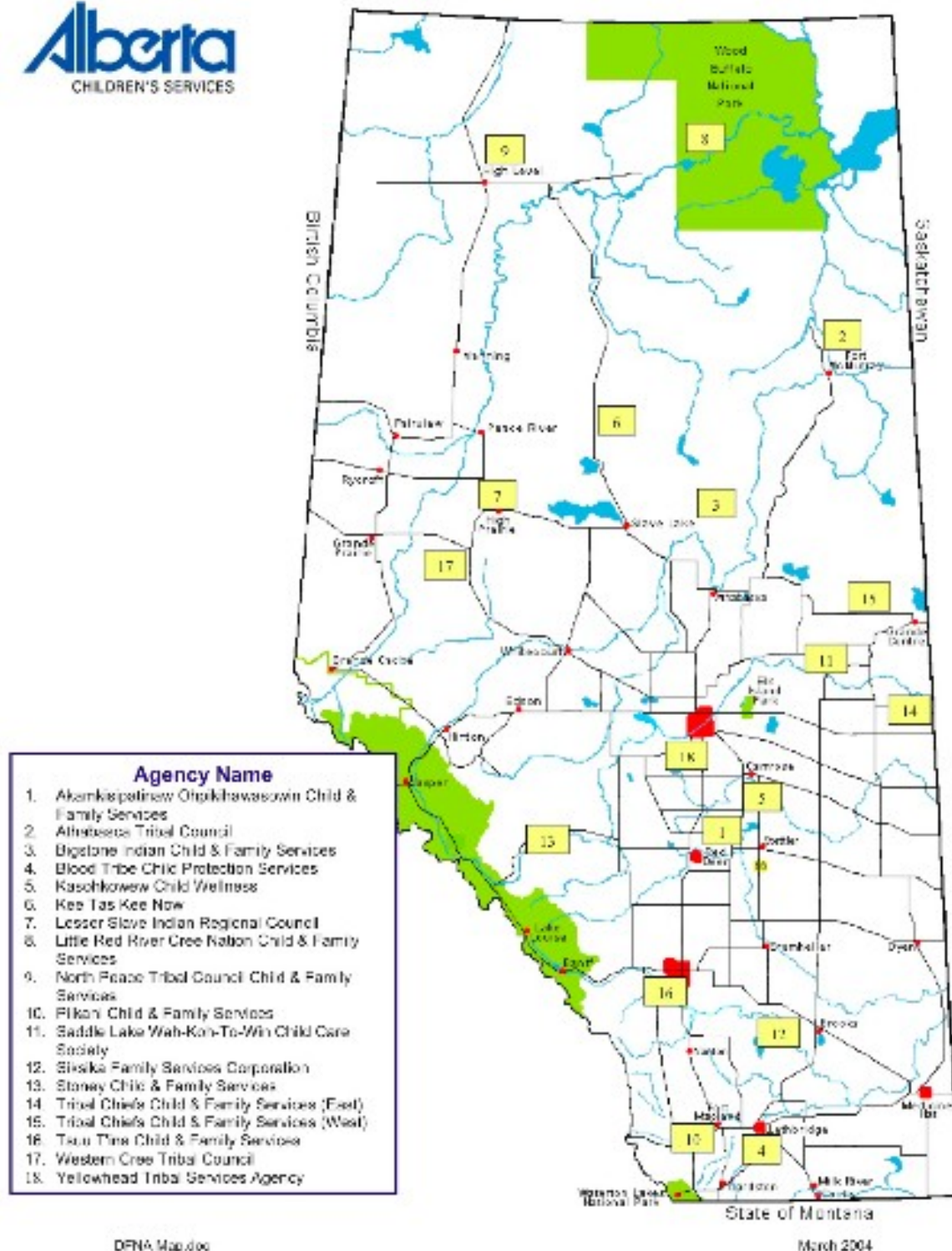
